



MSS® -HEMERA Re-Glass

Special Glass Cleaning / Restoration Agent

Features

It starts in areas where glass cleaners cannot find a solution. It is used safely in the glass manufacturing industry and in glass exterior cleaning. It is used in difficult to remove dirt, lime deposits, discolored glass, when efflorescence and freckling occur.

Attention; Re-Glass is an acidic product. Caution is required. It is not applied on metal-coated glass, household mirrors, tinned materials, polished surfaces. These warnings should not be used without careful testing and consulting an MSS specialist. Rubber gloves, goggles and protective clothing are worn during use.

Composition: Contains inorganic acid < 25 and alcohol < 5.

Physical Properties: Transparent colored liquid

Areas of Use

It is used on all glass and mirror glass surfaces, exterior cladding glass. Its application requires very special expertise. It can be applied by a professionally trained cleaning expert.

How to use

1. For heavily soiled glass; Pour Re-Glass concentrated into a plastic container (do not use a metal container). Apply to the glass surface to be cleaned with a clean brush to form a thin film layer. Rinse with plenty of water as soon as the dirt begins to dissolve within a minute. (Otherwise, the dirt will stick to the surface again). Re-Glass should be applied to the glass as soon as possible and should not remain on the surface. After cleaning, the glass will gain a new appearance. It can be diluted with water depending on the intensity of the dirt and the application can be repeated 2–3 times without dilution.

2. In cases of discoloration, efflorescence and bluing, in glasses stored in humid environments and in all glasses except metal-coated glasses, use; Spread on the glass with a clean brush. Wait for it to act on the glass for one minute and rinse with plenty of water. Blued glass is definitely cleaned. Glass surfaces are not damaged. It does not have a cleaning feature for worn or physically damaged glass. There is no guarantee of a definitive solution for white acid stains.

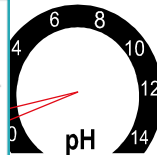

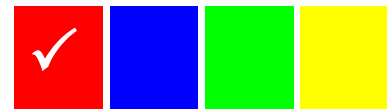
